Players must present a recent photo and copy of their birth certificate. Out of state teams must have proof of permission to Travel from their respective State Association.
6. The players on each first place team will receive individual trophies. Runners up will receive a team trophy.
7. Each youth league team will be required to remit \$15.00 referee fee for Rink B and \$20.00 for Rink A before the start of each game. This will be paid directly to the referee.
8. Each one day tournament team will be required to remit \$10.00 referee fee before the start of each game.

11. A combination of "House Rules" and FIFA rules will be used to ensure fun and safe play.
12. Indoor Soccer Shoes, Flats or Turf Shoes. No Cleats allowed.

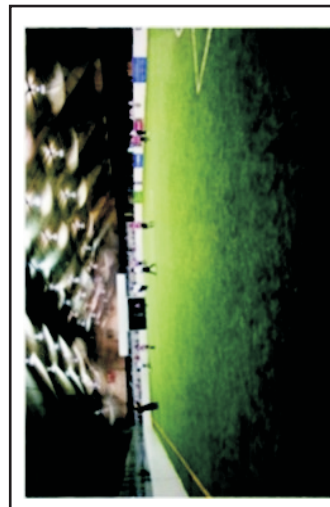
